The National Fire Fighter Near-Miss Reporting System received two reports regarding Carbon Dioxide (CO2) tanks in fast food restaurants. These reports can be viewed here. The Phoenix Fire Department has created an important firefighter safety alert and accompanying video which can be viewed on their website, www.phoenix.gov.fire. If you have experienced a nearmiss incident with CO2 tanks, please submit your report today. Information gathered on these types of incidents will help raise awareness of this hazard.

Steve Mormino as they discuss taking a proactive approach to firefighter/EMT safety by doing risk assessments using the Near-Miss Reporting System. The webinar will be posted by October 21st.

Use the Search Reports feature to look for reports that could have happened in your department. Use Advanced Search, the third search option, and enter parameters similar to your department. Then talk to your crew about how you would handle similar incidents.
